

Privacy policy for BizMaximizer

BizMaximizer ("we," "us," or "our") operates the BizMaximizer website ("Site"). This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our service and the choices you have associated with that data. By using the service, you agree to the collection and use of information in accordance with this policy.

1. Information we collect

We collect information from you in several ways to provide and improve our service.

Personal information

While using our service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you. This information may include, but is not limited to:

- Email address

- Usage data

Usage data

We may also collect information on how the service is accessed and used. This usage data may include information such as:

- Your computer's IP address
- Browser type and version
- The pages of our Site that you visit
- The time and date of your visit
- The time spent on those pages
- Unique device identifiers
- Other diagnostic data

Tracking and cookies data

We use cookies and similar tracking technologies to track the activity on our Site and hold certain information.

- **Cookies:** Small files stored on your device.

- **Tracking technologies:** Beacons, tags, and scripts to collect and track information and to improve and analyze our service.

2. Use of data

BizMaximizer uses the collected data for various purposes:

- To provide and maintain our service
- To notify you about changes to our service
- To allow you to participate in interactive features of our service when you choose to do so
- To provide customer support
- To gather analysis or valuable information so that we can improve our service
- To monitor the usage of our service
- To detect, prevent, and address technical issues

3. Retention of data

We will retain your personal data only for as long as is necessary for the purposes set out in this privacy policy. We will retain and use your data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

4. Transfer of data

Your information, including personal data, may be transferred to and maintained on computers located outside of your state, province, country, or other governmental jurisdiction where the data protection laws may differ from those in your jurisdiction. By submitting your personal data, you consent to that transfer.

5. Disclosure of data

BizMaximizer may disclose your personal data in the good faith belief that such action is necessary to:

- Comply with a legal obligation
- Protect and defend the rights or property of BizMaximizer
- Prevent or investigate possible wrongdoing in connection with the service
- Protect the personal safety of users of the service or the public
